

TERMS & CONDITIONS

Terms and conditions of the competition:

I agree that in the event of any breach of this agreement by the Company I shall not be entitled to injunct the competition and any legal remedy I may have shall lie in an action at law for damages only.

I hereby warrant that I have not entered into any commercial, sponsorship or other agreement or arrangement with any person, firm or company in respect of my entry in the competition and/or musical, musical writing and/or performing abilities and will not do so.
